Small spill	: Stop leak if without risk. Move containers from spill area. Use spark-proof tools and explosion-proof equipment. Dilute with water and mop up if water-soluble. 8.2 Exposure controls	
Appropriate engineering controls	: Use only with adequate ventilation.
