SECTION 4: First-Aid Measures

4.1. Description of first aid measures

First aid personnel should pay attention to their own safety. If the patient is likely to become unconscious, place and transport in stable sideways position (recovery position). Remove affected person from danger area. Immediately remove contaminated clothing. In all cases of doubt, or when symptoms persist, seek medical attention. Do not induce vomiting. Rinse mouth thoroughly with water, seek medical attention. If adverse health effects develop seek medical attention.

5.3. Advice for fire-fighters

Special protective equipment: Appropriate breathing apparatus may be required.

Further information:

Cool closed containers in the vicinity of the source of fire. Dispose of fire debris and contaminated extinguishing water in accordance with official regulations. Collect contaminated extinguishing water separately, do not allow to reach sewage or effluent systems.

SECTION 6: Accidental Release Measures

6.1. Personal precautions, protective equipment and emergency procedures

Avoid breathing vapours. For non-emergency personnel: Use personal protective clothing. Ensure adequate ventilation. Keep away from sources of ignition. SECTION 7: Handling and Storage

7.1. Precautions for safe handling

Provide good ventilation of working area (local exhaust ventilation if necessary). Do not return residues to the storage containers. Smoking, eating and drinking are forbidden in application area. For personal protection see section 8. Comply with the health and safety at work laws. When operators, whether spraying or not, have to work inside the spray booth, ventilation is unlikely to be sufficient to control particulates and solvent vapour in all cases. In such circumstances they should wear a compressed air-fed respirator during the spraying process and until such time as the particulates and solvent vapour concentration has fallen below the exposure limits. Avoid all sources of ignition: heat, sparks, open flame. Product may charge electrostatically: always use earthing leads when transferring from one container to another and earth containers. It is recommended that operators should wear antistatic clothing and footwear. Solvent vapours are heavier than air and spread along floors. Vapour forms explosive mixtures with air. The relevant fire protection measures should be noted. Use explosion-proof equipment.

7.2. Conditions for safe storage, including any incompatibilities

Keep away from oxidising agents, from strongly alkaline and strongly acid materials.

Hand protection:

Further information on penetration time is available from the manufacturer of the glove. Data are based on information from the glove manufacturer, the raw material manufacturer or according to specifics of the product components.
