4.1 Description of first aid measures

5.2 Special hazards arising from the substance or mixture

Contain and collect spillage with noncombustible, absorbent material e.g. sand, earth, vermiculite or diatomaceous earth and place in container for disposal according to local regulations (see Section 13). Protective measures
